
Challenges

Prior to Ukeru, WoodsEdge Learning Center was seeking to reduce their use of restrictive practices. Some of the behaviors leading up to these restrictive measures included aggression towards staff and peers, elopement, and self-injurious behavior. "These behaviors were dangerous enough to warrant emergency restraint and/or seclusion to keep staff and students safe", explained Jason Ervin, M.Ed., Behavior Support Specialist. They knew that there had to be a better way to support both their staff and students. Ukeru appealed to them as a partner due to the approach being trauma-informed, restraint-free, and containing a protective equipment component.

Working with Ukeru

WoodsEdge Learning Center began with a pilot of Ukeru in early 2022. After a successful 5-month pilot, they then trained their entire staff, totalling all together about 150 staff trained. To ensure a successful implementation, trainers met with administration, informed staff of the approach, created a parent letter to send home, and created a social story for classroom teams to read to their students about Ukeru and the use of the shields. Additionally, they made sure that their trainers were available to answer questions, held Q&A sessions during teacher and staff meetings, and had trainers readily available to observe, assist and model correct usage during crisis situations.

To further support the effort, they collected data on the number of emergency seclusions, restraints, injuries, and major property destruction. That data was compared for the same amount of time before implementing Ukeru with the time after implementation. They frequently shared this data with staff and administration to show the impact.



The results have been remarkable. WoodsEdge Learning Center has seen a dramatic decrease in the use of restrictive practices just 8 months after fully implementing Ukeru. "Our overall result has been incredibly positive. We are preparing to share those results with key stakeholders, parents, and community members", Ervin proudly shared.

Staff have provided positive feedback including that they feel safer with the shield component and feel better not having to put hands on kids that are in crisis. Ervin shared, "Staff have said that it's a good feeling to know that we will have students move through our program who never have to experience seclusion or restraint."
